

Accident Waiver and Release of Liability Form

We realize that no activity is without the possibility of unforeseen and foreseen hazards which could result in injury to an individual. As a parent or guardian, you are responsible to instruct your child of the importance of conduct which will insure safety and enjoyable time while participating in this activity. In consideration of my application and permitting my child to participate in this activity, I hereby take action for myself, my child, my executors, administrators, heirs, next of kin, successors, and assigns and by signing this form, I, as a parent, guardian or other responsible party, agree that:

- (a) My child is physically fit, has sufficiently been prepared or trained for participation in this activity, and has not been advised to not participate by a qualified medical professional. I further certify that there are no health-related reasons or problems which preclude my child's participation in this activity.
- (b) I acknowledge that this Accident Waiver and Release of Liability Form will be used by the event holders, sponsors, and organizers of the activity in which my child may participate, and that it will govern my and my child's remedies, actions, and responsibilities at said activity.
- (c) I assume the risks and hazards which are inherent in this kind of activity, including those risks and hazards that might arise from the participating and/or sponsoring organizations' negligence or carelessness. I also agree to absolve and hold harmless the sponsoring organizations, UW Sports Ministry and Holland Park Church, and their agents and representatives for damage, loss or injuries to the child for whom I am signing.
- (d) I WAIVE, RELEASE, AND DISCHARGE UW Sports Ministry and Holland Park Church and/or their directors, officers, employees, volunteers, representatives, and agents, and the activity holders, sponsors, and volunteers from any and all liability, including but not limited to, LIABILITY ARISING FROM THE NEGLIGENCE OR FAULT OF THE PARTICIPATING ORGANIZATIONS AND/OR SPONSORING ORGANIZATIONS, INCLUDING BUT NOT LIMITED TO UW Sports Ministry and Holland Park Church and/or their directors, officers,

employees, volunteers, representatives, and agents, and the activity holders, sponsors, and volunteers, for my child's death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to my child including my child's traveling to and from this activity; (C) I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in this release from any and all liabilities or claims made as a result of my child's participation in this activity, whether caused by the negligence of those released or otherwise.

This Accident Waiver and Release of Liability Form shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law. I CERTIFY THAT I HAVE READ THIS DOCUMENT AND I FULLY UNDERSTAND ITS CONTENT. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY, INCLUDING LIABILITY ARISING OUT OF NEGLIGENCE AND/OR CARELESSNESS AND A CONTRACT AND I SIGN IT OF MY OWN FREE WILL ON BEHALF OF MYSELF AND MY CHILD.

I give my child permission to participate in this activity, and give my permission to the leaders of this function to authorize any treatment deemed necessary by a licensed physician or nurse due to accident or illness during this activity.

I further give my permission for the use of any photo, video, or likeness of my child to be used by the sponsoring organizations for their use in promotional materials.
